



Terms and Conditions to go "FREEBALLIN"

Riders must adhere to all rules and regulations at our venue on the day of their event. Riders must remain courteous to staff at all times failure to do so may lead to you being asked to leave the venue without refund. Restrictions apply for both the splash ride and spin ride which can be found below. FREEBALLIN USA will assess height and weight restriction on the day of the ride and reserve the right to refuse a rider. FREEBALLIN USA judgment is final.

Retain the receipt for ride vouchers purchased online. Proper identification is required to redeemed ride vouchers purchased online. The Paypal order details are must be presented on the day of your event, one voucher will admit one person to a chosen ride (splash and spin). Failure to present identification and order information will lead to the full entry price becoming payable. The voucher cannot be used in conjunction with any other offer. Ride vouchers purchased online on valid for one year from date of purchase.

Refund Policy

Any refund is at FREEBALLIN USA's discretion.

Restrictions

The customer(s) cannot participate in FREEBALLIN ride if they are:

- Unable to produce pay the current ride price, or present an online ride voucher purchase receipt with proper ID.
- Under 8 years old for the splash ride (Parental consent is required up to the age of 18).
- Under 12 years old, or 52 inches in height for the spin ride (Parental consent is required up to the age of 18).
- Exceed 550 lbs. total weight for multiple riders.
- Exceed 275 lbs. for one person.
- Height and weight will be checked on the day of the ride, Downhill Ruckus judgment is final.
- Suffering from high blood pressure or heart condition.
- Suffering from epilepsy.
- Suffering from neck or back problems.
- Pregnant.
- Have relevant phobias.
- Under the influence of alcohol or drugs.

All participants are required to sign the waiver below before FREEBALLIN, false information could affect the safety and security of the staff and customers and invalidate the insurance. FREEBALLIN USA reserves the right to change the terms and conditions at any time without warning.
